
How to use the Summary of Decisions Requested – Corrigendum (SODR – Part C)

FURTHER SUBMISSIONS ON CORRIGENDUM

Further submissions are now invited on the additional submission points in the Corrigendum to the Summary of Decisions Requested only. The closing date for further submissions to be received by ORC is 5pm on Wednesday December 1, 2021.

A further submission must be limited to a matter in support of, or opposition to, a submission point in the Corrigendum to the Summary of Decisions Requested. A further submission must be in the form which is prescribed as Form 6 in Schedule 1 of the Resource Management (Forms, Fees and Procedures) Regulations 2003.
