I have lived in Brighton for 11 years, but my association with the area goes back over 60 years with my extended family have a crib in Brighton, where we enjoyed swimming and boating on the Otokia Creek. I oppose the application in its entirety for the following reasons. The application uses an assessment of the proposed site that is 30 years old, and even the most naïve could accept that the way in which we regard the protection of the environment now is not vastly different from back in the

1990's, and the value we place on the environment is far greater than then. The discharge permit
seeks to allow discharge of waste and leachate onto land, which by extension for this area will mean
discharge into the Otokia Creek - totally unacceptable to even consider such overt discharge of
toxins and waste water. In addition, the water permit seeks to divert surface water within the Otokia
Creek catchment and dam water in order to construct the landfill and also realign the road. Clearly
this will bring about the degradation of the Otokia Creek and the habitats of the flora and fauna in
the area. Incredibly the Land Use Consent openly seeks to alter, reclaim and place structures on the
bed of waterbodies and wetlands. We have already throughout New Zealand significantly reduced
the total area of wetlands so vital for our ecosystem - to propose this in such a cavalier way is
abhorrent. I am also concerned that the proposed landfill is so close to flight paths of planes landing
at Momona Airport and also the airport itself - certainly closer than accepted guidelines. The
Dunedin City Council and Counsellors have failed to plan for an alternative Landfill site to Green
Island over many years. Now they have proposed a plan that is short-sighted, and ill-conceived. The
haste with which this proposal was submitted and the attempt by the Dunedin City Council to have
this Resource Consent Application non-notified, suggests a desire to get this application accepted
without too much scrutiny. As such I feel the Dunedin City Council is not behaving as a trust-worthy
body and question where they can be relied on to adequately operate a landfill on this site in the
proper manner. This proposal for the landfill to be established at Smooth Hill must be stopped,
