I Oppose the application because:

1. Brighton/Ocean View has one of the most beautiful coastlines in New Zealand it is popular with tourists. Brighton Beach is enjoyed by my family and friends from all over NZ and Australia, for swimming, surfing, relaxing and watching birdlife. It is a popular and safe beach for families with small children. I am concerned that leaching of toxins, unpleasant odours, and airborne rubbish



and dust from a landfill will forever destroy this little paradise and make swimming unsafe and unpleasant.

- **2.** Commercial, recreational and emergency rotary and fixed-wing aircraft fly directly over or close to the proposed landfill site. Bird strike is a real concern. It increases the risk of accidents causing damage and loss of life. Control of the birds with methods such as poisoning or trapping and shooting is totally unacceptable, costly to the rate payer and adds to toxins and pollution.
- **3.** Brighton/Ocean View is a small community that has limited resources in the case of an emergency. All landfills have the potential for leaching of toxins, airborne toxic gases and for fire risk. Brighton Fire Brigade is manned by volunteers and would struggle to contain a major fire at a land fill that is surrounded by pine forests that stretch vast distances extending through and running close to grazing land, native bush and residential properties..
- **4** There is a strong evidence that the preservation of wet lands, wildlife and water ways is essential to the health and protection of the environment. Its disturbing that council wants to proceed with this project that would destroy an existing wet land and its wildlife, it could also cause problems and potentially render a beautiful recreational area a health hazard which could create serious and expensive repercussions into the future.

If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

You must serve a copy of your submission on the applicant as soon as is reasonably practicable after you have served your submission on the consent authority.

Privacy: Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process

If you are a trade competitor, your right to make a submission may be limited by the trade competition provisions in Part 11A of the Resource Management Act 1991.

If you make a request under <u>section 100A</u> of the Resource Management Act 1991, you must do so in writing no later than 5 working days after the close of submissions and you may be liable to meet or contribute to the costs of the hearings commissioner or commissioners.
