I am Margie Bell, I was brought up at Brighton, am now a Brighton ratepayer and am here to speak to my objection to the DCC resource consent application #RM20.280.

This application appears to have been made in order to circumvent new and relevant regulations from the ORC.

It is therefore not made in the spirit of local body co-operation nor in the interests of rate payer support.

This has caused questions of both trust and expediency to surround the DCC Smooth Hill landfill application.

In addition, the environmental care record of the DCC such as the long term poisoning of the Kaikorai Valley stream, the Sth Dunedin floods and the continuation of pumping sewerage out into the ocean within the vicinity of our beaches does not inspire confidence in their assurances or abilities to prioritise the environment at any level.

For other details of environmental problems in this landfill R.C. application, these are contained within the form of application itself which was notifiable due to the adverse environmental effects of substances accepted at landfill such as asbestos, chemicals etc. I refer also to the information relating to landfill toxicity provided by the ORC.

**ENVIRONMENTAL LOCATION.**

Smooth Hill is at the headwaters' catchment for the stream and wetlands.

These waterways act as filtration systems for estuaries, are home to flora and fauna which all act in concert and are necessary support to the wider eco system. Toxic landfill is not and should not be a part of any ecosystem.
