Our submission is we do not support the land fill as it will threaten our beach and surrounding areas.

Otokia creek runs right through into Brighton beach and any land fill will be harmful to beach goers and the community who swim at the beach. The Surf Club has been there for more than 75 years with surf life guards providing a service to the community keeping the beach safe. We train all our life guards there and we use the beach all year round. The land fill will be harmful to all beach goers and future generations of beach users. Mother nature can change the Otaki creek which means after a big storm the creek empties into the middle of the beach and without the proposed land fill we have had to close the beach due to high levels of bacteria (E.coli) noted in the water. Will the land fill also dirty the creek even further causing even more danger to the community? We currently average 100 plus swimmers in the water during the summer months based on our figures gathered during the patrol season. In the creek we can have hundreds of families enjoying this area. We also have protected penguins and wild life on the beach the land fill will affect these protected species.

The construction of a land fill will result in roads which will displace the lizards and falcons, changes to the quality of water will also endanger the oyster catchers and blue eyed penguins both endangered species. Page 58-61 ORC notification recommendation report.

If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

Privacy: Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process
