My family home in Brighton is situated on the river bank along the Ōtokia Creek where I live with my wife and two children. My children and I swim in the creek, as I swam in the Ōtokia at Brighton Beach with my parents when I was a child, and as my parents and grandparents did when they were young. The Ōtokia Creek at Brighton Beach is currently a favorite calm water swimming spot for Dunedin families with young children, as it has been for generations. I anticipate that if a landfill is built in the headwater stream gully of the Ōtokia, this will no longer be the case. I have decades of experience in civil construction and engineering in some of the largest mega-projects ever built in Australasia. I have read every detail of the assessments provided to support the application to operate a landfill at Smooth Hill. I have little confidence that the risk of contamination is too high to allow my family to swim in the creek, with my own subject matter expertise, then it is clear that the general public will no longer view the Ōtokia Creek as a safe place to swim. The perception of risk that a accompanies a landfill situated within a tributary of the creek will change the way our community interacts with the waterway forever, and degrade the well-being of the greater Dunedin community.

It concerns me that the applicant has not assessed alternative locations since the 1990s. Given how our understanding of waterway management has changed in the last 30 years in New Zealand, it is clear that Smooth Hill would not proceed had it been assessed in recent years. Whats more the recent assessment by the applicants consultants is of a poor quality, with eccological values underestimated, fish surveys incorrectly carried out at the wrong time of year. Even the archeaological assessment seems to have large gaps in it's conclusions (ODT 'historical treasure at propsed tip site' 12/8/20)

Recent research by seismologists have shown an increased threat from fault lines in the area. The Titri and Akatore faults among others have been reevaluated and now carry a higher probability and more significant impact than previously thought (ODT 'On shaky ground' 26/9/20). The landfill liner has not been engineered with this risk considered. The proposal also does not consider the effects from climate change of increased and more severe rain events. The proposal is based on a 'business as usual' scenario that simply will not exist in the future.

The Ōtokia Creek has seen a rejuvenation in recent years and the health and quality of the creek and its fauna are on an upward trajectory. This landfill would see a large and irreversible backward step taken in regards to the health of the waterway.

If you are making a submission to the Environmental Protection Authority, you should use form 16B.

The closing date for serving submissions on the consent authority is the 20th working day after the date on which public or limited notification is given. If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

You must serve a copy of your submission on the applicant as soon as is reasonably practicable after you have served your submission on the consent authority.

Privacy: Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process

If you are a trade competitor, your right to make a submission may be limited by the trade competition provisions in <u>Part 11A</u> of the Resource Management Act 1991.

If you make a request under <u>section 100A</u> of the Resource Management Act 1991, you must do so in writing no later than 5 working days after the close of submissions and you may be liable to meet or contribute to the costs of the hearings commissioner or commissioners.
