- 1 This is a further submission on the Proposed Otago Regional Policy Statement 2021 (**PORPS**).
- 2 Universal Developments Hawea Limited (**Further Submitters**) are persons representing a relevant aspect of the public interest and who have an interest in the proposal that is greater than the interest the general public has.
