- 5 Ms Fenemor's supplementary evidence on *HCV Historical and cultural values*¹ recommends a change to the description of the region (including historic heritage) to be included in Part 1 of the RPS. The specific amendments to these provisions are set out in that statement of supplementary evidence and therefore I do not repeat them here. I have reviewed the recommended changes of Ms Fenemor and agree with her recommendation.
- 6 Consequentially the following text should be included in Part 1. The text should be included at the beginning of paragraph 5, within the 'Description of the Region' section within Part 1:

Otago's history recognises the early exploration and occupation of Otago by Kāi Tahu followed by the arrival of settlers from Europe and Asia.²
