You will need to pay a deposit of \$1,900 when you lodge this application and include an [Intensive Winter Grazing management plan](#).




2. To complete the form as a Guest User continue and complete the form on the screen. **As a Guest User you will not be able to save a part-completed form.** To save a part-completed form you will need to set up an online account before you begin.
3. To log in with an existing account or to sign up for an account, click on the 'LOG IN' option at the top right of the screen:
