PURPOSE

[1] To consider and adopt a committee structure for the Otago Regional Council for the 2022-2025 triennium. This structure can be reviewed at any point during the triennium.

EXECUTIVE SUMMARY

- [2] The Chairperson of the Otago Regional Council, following discussions with members, recommends the attached committee structure for the Otago Regional Council for the 2012-2025 triennium.
- [3] Recommendations for the co-chairs of the committees have also been made.
- [4] Recommendations to invite mana whenua representatives onto the Environmental Policy and Science Committee, and Regional Leadership Committee, and an independent member onto the Audit and Risk Subcommittee are also included.
- Once a committee structure has been adopted, terms of reference and delegations will be developed and be presented for Council consideration and adoption.
- [6] It is proposed to review the committee structure in 18 months' time, following the adoption of the next Long-term Plan, to ensure it remains fit for purpose.

RECOMMENDATION

That the Council:

- 1) **Notes** this report.
- 2) **Adopts** the new committee structure attached to this report.
- Approves the appointment of co-chairs to the committees as listed in the attachment.
- 4) **Approves** inviting mana whenua to nominate two representatives to be members of the Environmental Policy and Science Committee, including one as co-chair (nominations will be brought back to Council for confirmation).
- 5) **Approves** inviting mana whenua to nominate one representative to be a member of the Regional Leadership Committee (nomination will be brought back to Council for confirmation).
- 6) **Approves** the Chair nominating an independent member to Chair the Audit and Risk Subcommittee (nomination will be brought back to Council for approval).

- 7) **Notes that** a further list of Council appointments to various internal and external working groups will be presented for consideration at the December 2022 Council Meeting.
- 8) **Notes** the updated delegations and terms of reference for each committee and subcommittee will be brought to a future meeting for consideration and approval.

BACKGROUND

- [7] The Local Government Act 2002 gives local authorities the power to appoint committees, subcommittees and other subordinate decision-making bodies that it considers appropriate (Section 30, Schedule 7).
- [8] Council and its committees are the key vehicle for enabling democratic local decision-making. Meeting agendas and papers are in large-part publicly notified, and the public is welcome to attend. When necessary, council and committees can be designated public-excluded for a range of reasons.
- [9] Iwi representatives have been appointed on the Strategy and Planning Committee since 2019. An independent member has also been appointed to the Audit and Risk Subcommittee. Clause 31(3) of Schedule 7 of the Local Government Act enables this.
- [10] This Local Government New Zealand <u>Decision making quide, draft summary 2019</u> has some useful background on committee structures.
