I oppose the application as I think we need to protect our rivers for humans to enjoy and recreate and enjoy nature, and also protect all the all the species that the river supports. Rivers are precious. We need to protect them. The idea of dredging the riverbed is horrific. Imagine the complete destruction of ecosystems that will create and the affect on water quality – which must have a flow on affect to critters that live in the river. Imagine a big dredge ripping through your home. Very uncool!



But seriously, we need to be protecting our waterways not destroying and/or degrading them. So I oppose the application in terms of the potential environmental impact.

I also oppose the application in terms of the visual impact of a big dredge on the river which lessens the wilderness experience for river users such as kayakers, swimmers, divers etc. Rivers are a place to get away and enjoy nature. A big dredge on the river will change this experience.

I also oppose the application based on the potential affects on water quality. This dredge has two Detroit Diesel TWO STROKE main propulsion engines. The vessel has wet exhausts that mix the engine exhaust gas with engine cooling water that is then discharged directly into the river. Detroit Diesel no longer manufactures these engines due to their negative environmental impact. They are no longer certified to operate in many parts of Europe and North America. Two stroke diesel engines produce a lot more pollution due to the fuel air mix being contaminated by the engine lubrication oil. Two stroke engines emit around ten times more pollution when compared to four stroke engines. If you are making a submission to the Environmental Protection Authority, you should use form 16B.

The closing date for serving submissions on the consent authority is the 20th working day after the date on which public or limited notification is given. If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

You must serve a copy of your submission on the applicant as soon as is reasonably practicable after you have served your submission on the consent authority.

**Privacy:** Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process

If you are a trade competitor, your right to make a submission may be limited by the trade competition provisions in Part 11A of the Resource Management Act 1991.

If you make a request under <u>section 100A</u> of the Resource Management Act 1991, you must do so in writing no later than 5 working days after the close of submissions and you may be liable to meet or contribute to the costs of the hearings commissioner or commissioners.
