I fully support this application for the reasons listed below:

Accessible accommodation for people in wheelchairs. It is very difficult to find wheelchair accessible holiday accommodation, this would be an amazing place to stay. A semi remote area with accessible accommodation & options for water based activities would hugely benefit the disability community as this is rarely available in New Zealand

Having the floating pontoon & crane hoist to allow disabled people access to boats, canoes & the water safely would allow enjoyment of water activities for so many people. Allowing organisations/charities that work with the disabled community (eg. Parafed Otago) access to this would give disabled/mobility challenged people the chance to enjoy water based activities that are

normally difficult & non existent to access.

Allowing emergency services access to the floating pontoon/wharf benefits everyone that uses the water & should they find themselves in need of help, a safe place to be safely bought to land & help given.

I am in a wheelchair & it's a struggle to still be able to do things that I did before my injury, with ease. Yes, I can stay in a standard chain hotel/motel room in a busy city but to be able to stay somewhere more unique would be fantastic.

I love getting out on a boat with my friends but its not easy. The tides have to be right, I need strong people to lift me & my chair onto the boat. I enjoyed kayaking, paddle boarding & swimming in the sea/river/beach but now all these activities are next to impossible due to ease (of lifting) & access. The options that would be available at this premise would allow me to partake in the things I did before wheelchair life & in a place where I spent my holidays as a child.
