


Proposed Regional Policy Statement for Otago



Otago's future

Mō tātou, ā, mō kā uri ā muri ake nei For us and for the generations that come after us

This brochure tells you about the Proposed Regional Policy Statement for Otago, how it affects you, and how to get involved.

The Proposed Regional Policy Statement aims to ensure Otago's natural and built resources are managed well, now and for the future.

Well managed resources provide for Otago's social, economic, cultural and environmental wellbeing; community health and safety; and for future generations.

The Proposed Regional Policy Statement affects you because it guides development of district and regional plans, and resource consent decision making.



The Proposed Regional Policy Statement:

Has four outcomes:

- Kāi Tahu values, rights and interests are recognised and kaitiakitaka (exercise of customary custodianship) is expressed
- Otago has high quality natural resources and ecosystems
- Communities in Otago are resilient, safe and healthy
- People are able to use and enjoy Otago's natural and built environment

Considers the needs of all of Otago's communities by:

- Addressing matters of regional importance
- Focusing on values and effects of using resources, and land use activities
- Requiring environmental bottom-lines to be set
- Enabling use of resources, and land use activities, unless there is good reason for them to be avoided or managed
- Reflecting the connections in the natural and built environment
- Using common descriptions for values to help make consistent planning decisions
- Assisting city, district and regional councils to work well together.

The Proposed Regional Policy Statement includes proposals that affect you:

Kāi Tahu values, rights and interests

We need to honour Te Tiriti o Waitangi (the Treaty of Waitangi) by including Kāi Tahu values, rights, and interests in our planning processes. Resource management needs to give effect to the Treaty and recognise that customs evolve over time, while enabling customary use of land and other resources.

Significant values

Some things are so important to us that we need to be extra careful in how we manage them, and we should do this consistently across Otago. We propose the use of common criteria identifying indigenous vegetation, habitat of indigenous fauna (animals), natural features, natural landscapes, and heritage.

Natural hazards

Risk from natural hazards should be minimised, and reduced wherever possible. Communities affected by natural hazards will be involved in assessing their ability to tolerate natural hazard events and how best to minimise risk to life and property.

Climate change and sea level rise

The effects of climate change over the next 100 years should be considered. A sea level rise figure of one metre is proposed to recognise the effect of climate change. This figure must be taken into account when future resource management decisions are made.

Land use change in dry catchments

Any changes of land use that reduce available water in Otago's dry and vulnerable catchments should be carefully considered. We propose that significant changes in vegetation, such as tussock grassland conversion and forestry extension, need to be managed appropriately in drier parts of the region.

Air quality

It is important for our health that we have clean air and warm homes. Where there is already poor air quality, or in areas where air quality is at risk of being degraded, it is proposed that new subdivision and development must use low or no-emission heating systems.

Urban areas

Different planning approaches may be needed to ensure our urban areas are vibrant and productive. Some urban areas, like in the Queenstown Lakes District, are experiencing strong population growth, while other parts of the region want to attract people and investment.

Managing the effects of urban areas and the costs of infrastructure on our communities is a major issue regardless of the rate of growth. Urban growth boundaries may be used where extra care is necessary to ensure infrastructure is used well and stays affordable, or to protect valued rural land. The use of good urban design is supported.

Public notice of Proposed Regional Policy Statement for Otago

The Otago Regional Council gives notice that it has prepared the Proposed Regional Policy Statement for Otago (Proposed RPS). The Proposed RPS sets out how we will achieve integrated management of Otago's natural and physical resources.

The Proposed RPS has four outcomes:

- Kai Tahu values, rights and interests are recognised and kaitiakitaka (exercise of customary custodianship) is expressed
- · Otago has high quality natural resources and ecosystems
- · Communities in Otago are resilient, safe and healthy
- People are able to use and enjoy Otago's natural and built environment

The Proposed RPS aims to consider the needs of all of Otago's communities by:

- Addressing matters of regional importance
- Focusing on values and effects of using resources, and land use activities
- Requiring environmental bottom-lines to be set
- Enabling use of resources, and land use activities, unless there is good reason for them to be avoided or managed

- After submissions close, Council prepares a summary of decisions requested and publicly notifies it
- Certain persons may make a further submission supporting or opposing submissions already made
- You may speak in support of your submission at a hearing
- The Council gives notice of its decision on the proposal, including its reasons
- Every person making a submission has the right of appeal to the Environment Court
