As you are aware, there have been discussions occurring between the Applicants for this consent and the Applicants in RM16.093.01 with respect to their respective applications. The purpose of those discussions has been to see whether the parties can achieve an 'agreed approach' to their respective applications that provides certainty in assessing the effects of the individual applications and the cumulative effects of them. We are pleased to advise that an agreement has been reached and as such LIC/LM seek to amend its application.
