Strategy & Planning Committee Terms of Reference

Purpose

Assist the Council set the organisation's mission, vision and strategic direction (the 'strategic plan'). Monitor performance against the strategic plan. Develop and recommend to Council strategies, policies and plans informed by science that enable the ORC to deliver on its strategic plan and its legislative requirements. Assess the effectiveness of strategies, policies and plans.

Reporting

The Strategy & Planning Committee reports to the Council.

Membership

Co-Chairs: Cr Marian Hobbs & Cr Michael Laws

The Strategy & Planning Committee shall have a membership of all elected Councillors plus two lwi representatives with full voting rights.

A quorum of the Strategy & Planning Committee shall be seven members.

Meetings

The Strategy & Planning Committee will have:

- Ordinary meetings at 8 weekly intervals;
- Three to five half day workshops at a minimum of four monthly intervals; and
- Other meetings or workshops as required.

Key Responsibilities

The Strategy & Planning Committee will:

- Periodically review and make recommendations to Council in relation to ORC's mission, vision, strategic initiatives, major programmes and services
- Understand and keep abreast of trends in ORC's external operating environment including national legislative trends as they relate to ORC's functions
- Make submissions to other authorities and government
- Assist in the identification of critical strategic issues facing the organisation and make recommendations on options to address these
- Review the strategic plan and recommend updates as needed based on changes in the ORC's external operating environment
- Monitor and report on the organisation's performance against its strategic plan
- Oversight of the environmental monitoring programme to ensure it supports ORC's strategies, policies and plans
- Review of the State of the Environment monitoring, analysis and reporting
- Oversight of the development of scientific evidence that informs the development of ORC's strategies, policies and plans
- Provide policy guidance and direction in respect of the preparation or amendment of any plans over which it has oversight
- Periodically review and make recommendations to Council in relation to strategies, policies and plans for specific ORC's functions particularly those that arise from legislative requirements
- Monitor and report on the effectiveness of ORC's strategies, policies and plans

• Maintain oversight of risks associated with strategy and planning functions.

PURPOSE

- [1] Otago Regional Council's Science team generate scientific and research reports which may be used by other groups within ORC for environment and resource management.
- [2] ORC Science's scientific and research reports will be presented to the Strategy and Planning Committee for noting.

SUMMARY

- [3] Report title: A review of water quality and ecological data for the Manuherekia River Catchment (June 2019). The report was prepared by N. Hudson and J. Shelley (NIWA).
- [4] NIWA was engaged by Otago Regional Council (ORC) Science to provide an assessment of selected water quality and ecological data for the Manuherekia River catchment in Central Otago. This study confirms that the information analysed provides an effective benchmark against which future ecological condition assessments of catchments can be compared.
- [5] A precis of the report follows:
 - a. In general, based on the data made available to prepare the report, water quality and ecosystem health in the Manuherekia River mainstem are fair to good, evidenced by macroinvertebrate index (MCI) values ranging from 90 to 120. The semi-quantitative MCI (SQMCI) scores were greater than 4 (fair), with most macroinvertebrate samples collected in 2016/17 (10 of 18) indicating good to excellent condition. The exception appears to be the Loop Road site, where lower MCI and SQMCI scores in 2016/17 were consistent with greater periphyton growth. The Falls Dam regulates flows in the upper Manuherekia River, and to some extent reduces the discharge of sediment to the lower catchment this is evident from the relatively low turbidity values at the Loop Road site.
 - b. Both trout and various native fish species inhabit that Manuherekia River catchment, where Dunstan Creek may provide a critical refuge for the roundhead galaxiid.
 - c. Flows in the Manuherekia River during the 2016/17 ecological survey period were generally above what might be considered 'low flow' conditions, reflecting the high flows that extended into summer 2016/17, as well as several rainfall events. These 'atypical' flow conditions mean caution is required when evaluating the periphyton data (which may be more extensive in a period of lower flows), which in turn will also impact macroinvertebrate communities.
