Rebecca,

Thanks for your time on the phone just now. Regarding the 14 January further information request for the New Beaumont Bridge resource consent, our intention is to not provide any further information at this stage and request that ORC proceed with public notification of the application as it stands. There will be unresolved aspects on the visual assessment and flooding which we would endeavour to address in parallel with the public notification and hearing processes. If possible, we would be keen to notify by the end of next week to keep the process moving.

We will also confirm the query on the defence against water first thing next week once Shane returns (I expect this will be confirmation that we are seeking consent for this as a discretionary activity).

If you are able to discuss the above with your manager and come back to me that would be appreciated.
