The specific parts of the application/s that my submission relates to are: *(Give details)*

Appin Farms Limited ("Appin") farms land upon which part of the proposed activity will be undertaken, and adjacent to the proposed activity.

Appin is a sub-lessee from the trustees of the Appin Family Trust which leases the land from the applicant.

The woolshed and associated facilities are within the proposed activity area and the proposed activity may have incidental effects on Appin's farming activity.

The applicant has consulted with Appin about these effects and proposes to address them, primarily by reinstating the woolshed and associated facilities outside of the area of the proposed activity. If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

You must serve a copy of your submission on the applicant as soon as is reasonably practicable after you have served your submission on the consent authority.

Privacy: Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process
