MEMORANDUM 1 TO PARTICPANTS

6 July 2020

PURPOSE

This memorandum sets out the statutory process leading up to hearing of these applications.
The hearing is scheduled to commence at 9.30AM on Wednesday 19 August 2020 at Dunedin
Venues, Conference Room 1, Town Hall building in the Octagon, Dunedin.

BACKGROUND

2 The Applicant has applied for a suite of resource consent applications associated with the proposed Deepdell North Stage III Project. The proposed project involves three main components: the re-mining of the existing Deepdell North mine pit and extending it from 18.7ha to 38ha; the creation of a new waste rock stack covering 70.6ha; and the re-alignment of a 900m section of Horse Flat Road. Associated activities include discharges to air and water, and the diversion and/or reclamation of several small watercourses.

- 3 A number of applications have been made to each of the Otago Regional Council (ORC) and the Waitaki District Council (WDC). The ORC is the administering authority for the hearing.
- 4 A hearing panel has been appointed, comprising WDC Councillor Jim Hopkins and independent commissioner Dr Brent Cowie (chair). The panel will hear and decide the applications jointly.
- 5 The applications were publicly notified with submissions closing on 29th May 2020. Six submissions were received from Appin Farms Limited, Neil J. Roy, Macraes Community Incorporated, Aukaha, Director-General of Conservation (Department of Conservation), and the Otago Regional Council. Of the six submitters, five stated that they wish to be heard.

STATUTORTY TIMETABLE

6 The Resource Management Act 1991 (the RMA) prescribes a process leading up to a hearing that involves pre-circulation of: one of more "Officer Reports" prepared under the provisions of S42A of the Act; and any expert evidence that the applicant or submitters intend to call.

11 Pursuant to section 41B of the RMA, any expert evidence to be called by the applicant must be supplied to Karen Bagnall, Otago Regional Council by **2pm on Tuesday 4 August 2020.**

Submitters' Expert Evidence

- 12 Pursuant to section 41B of the RMA, any submitter who intends to call expert evidence must supply to Karen Bagnall, Otago Regional Council by **2pm on Tuesday 11 August 2020**, a copy of any statement of expert evidence the submitter intends to call at the hearing.
- 13 The above direction to submitters relates only to any expert evidence they intend to call. It does not apply to statements by lay witnesses and submitters themselves. Evidence presented by lay witnesses either orally or (preferably) in writing is welcome at the hearing.

- 14 The applicant and submitters should supply copies of their evidence in electronic pdf format (or, alternatively, one printed copy) to Karen Bagnall by the deadlines stipulated above.

HEARING PROCEDURE

- 16 The hearing will commence with the applicant's case. This will be followed by submitters to the application, and next from the reporting officer(s) (whose report(s) will be taken as read) before the applicant's right of reply.
- 17 The reporting officers are encouraged to give written updates of the matters that have arisen during the hearing when they give their presentations.
- 18 Submitters who wish to be heard are asked to liaise Karen Bagnall as to when may be an appropriate time for them to present their submissions and/or evidence. A draft timetable will be provided before the hearing, and may be updated as the hearing proceeds.
- 19 Pre-circulated expert evidence will be taken as read. Experts appearing for the applicant or submitters may prepare a short presentation summarising their evidence (such as via Power Point). This should not take more than 20 minutes. Copies of any such presentation should be sent to Karen Bagnall by Monday 17 August, so they can be loaded on to a hard drive.
