Topic 1: Are we focusing on the right things in the plan?

Topic 3: Should we increase our passenger fares?

Our proposal: we are considering increasing the base fare for adult Bee Card passengers from \$2 to \$2.50. This would effectively increase bus fares for all passengers using Bee Cards by 25%. **What do you think about this proposal?**

I think \$2.50 fares strikes the right balance. Of course everyone would prefer lower! But in light of the (unfortunate) Central Government directives, cost increases to fund growth/improvement in the network, and inflationary pressures, I'd accept an increase to \$2.50 and continue to use the bus regularly (perhaps slightly less often if I can help it!)

Topic 4: Should we charge more for longer trips?

Our proposal: we are considering introducing a zone fare system to our bus networks in Dunedin and Queenstown. Under this system, passengers travelling further distances across multiple zones will pay a higher fare than those travelling short distances within one zone. **What do you think about this proposal?**

Firstly, the proposed zone map wasn't the clearest. We catch the 50 bus to Helensburgh and I'll assume we would be zone 1.

I think it makes sense that the costlier routes should be charged higher fares. I trust the Council will not make the increased charges too high, as a Dunedin patron I would still like to see high patronage for outerzoned routes as more of an ORC priority than revenue gathering.

Topic 5: Should we keep our free fares for children (5-12 years)?

Our proposal:

- A. Retain free fares (100% discount) for children (5-12 years), AND
- B. Standardise our concession discount for youth (13-18 years) to 40% across both the Dunedin and Queenstown networks. For example, if the adult fare is \$2, youth pay \$1.20, or if the adult fare is \$2.50, youth pay \$1.50.
