## Topic 5: Should we keep our free fares for children (5-12 years)?



- B. Standardise our concession discount for youth (13-18 years) to 40% across both the Dunedin and Queenstown networks. For example, if the adult fare is \$2, youth pay \$1.20, or if the adult fare is \$2.50, youth pay \$1.50.

Basic bus infrastructure was not included in the bus hub. Several stops do not have any shelter from the weather (ive literally had several tourists stop and comment to me about it while walking past, its a constant topic of complaining at the stops on bad weather days) Several stops have either no seating, very



little or extremely uncomfortable narrow seats im I'm unable to use so i end up sitting on the ground. In wet weather there's nowhere to sit at my stop. I have a disability, I NEED to sit. These are extremely basic needs. No-one wants to stand in the rain or snow simply to catch a bus, no-one wants to be forced to sit on the ground due to narrow or absent seating.

There's an actual shelter placed at the stop I use to get home from after the Dr, but again there's no seating so in bad weather the fence nearby can't be used to sit on.

Sick,tired,elderly,young,pregnant, we all need to sit but we currently can't
