I fully support the bus system in Dunedin. It works very well for me - so well done and thank you!

What I AM concerned about is that when the Bee Card is transferred to the new Motu Move system in late 2025-2026, any balance left on the Bee Card would not be refunded or could not be transferred to the new Motu Move card!

I am a Pensioner and have Gold & Community Services cards. I have \$26 on my card at present and can't see how I can take 26 'paying' rides (\$1) between now and 2026. I may end of with \$5-\$10 left on my card by then.

There are 280,000 Bee Cards in circulation in NZ (if what I read in the paper is true) so if every card had \$1 on it, you would pocket \$280,000! But some cards will have more than that (a bus driver friend told me some have as much as \$80!)

Also, having spoken to several friends about this, I find they were not aware they will lose their remaining balance!

When I mentioned this at a recent ORC drop in session I was told it was 'probably a finance thing and too expensive to administer'! I was appalled by this response!

Then to top it off I am asked if an increase in bus fare is reasonable? In isolation, I would say yes - but not when you have just stolen my money!

Topic 2: Should we support community transport services in smaller towns and rural areas?

Topic 3: Should we increase our passenger fares?

Our proposal: we are considering increasing the base fare for adult Bee Card passengers from \$2 to \$2.50. This would effectively increase bus fares for all passengers using Bee Cards by 25%. **What do you think about this proposal?**

As mentioned above - Council have announced that the Bee Card will be taken out of service and replaced with a Motu Move card in late 2025 / early 2026 in Dunedin.

Topic 4: Should we charge more for longer trips?

Our proposal: we are considering introducing a zone fare system to our bus networks in Dunedin and Queenstown. Under this system, passengers travelling further distances across multiple zones will pay a higher fare than those travelling short distances within one zone. **What do you think about this proposal?**

Topic 5: Should we keep our free fares for children (5-12 years)?

- A. Retain free fares (100% discount) for children (5-12 years), AND
- B. Standardise our concession discount for youth (13-18 years) to 40% across both the Dunedin and Queenstown networks. For example, if the adult fare is \$2, youth pay \$1.20, or if the adult fare is \$2.50, youth pay \$1.50.
