Register of Pecuniary and Other Specified Interests for Councillors of Otago Regional Council

The requirements of the Local Government Act 2002 (Subpart 3 of Part 4 – Register of members’ pecuniary interests) direct local authorities to keep a Register of pecuniary interests of elected members and to make a summary of this Register publicly available. These requirements came into effect on 20 November 2022.

The Register records Councillor interests to provide transparency and to strengthen public trust and confidence in local government processes and decision-making.

Councillors are required to provide this statutory pecuniary interest return annually and to update this return throughout the year as changes occur.

Under the Act, Otago Regional Council provides an overview of the Register's requirements (see below), followed by a summary of each Councillor's annual return for the relevant 12-month period:

1. Are you or your spouse/partner the director of a company? (section 54E(1)(a); CoC Cl 9(b)).
2. Do you hold or control more than 10% of the voting rights in a company? (section 54E(1)(a)).
3. Do you or your spouse/partner have a pecuniary interest in any other company or business entity (except as an investor in a managed investment scheme)? (sections 54E(1)(b) and (2)); CoC Cl 9(b).
4. Are you or your spouse/partner employed? (section 54E(1)(c)); CoC Cl 9(a).
5. Do you have a beneficial interest in a trust (section 54E(1)(d)).
6. Are you a member of an organisation, a member of the governing body of the organisation, or a trustee of the trust and that organisation or trust receives, or has applied to receive, funding from the Council, local board or community board to which you are elected? (section 54E(1)(e)).
7. Are you appointed to any organisation by virtue of being an elected member (section 54E(1)(f)).
8. Do you have a legal interest, other than as a trustee, in any real property within ORC's jurisdiction? (section 54E(1)(g)).
9. Are you the beneficiary of a trust that holds real property (but excluding a trust that is a unit trust you have already disclosed under question 5 or a trust that is a retirement scheme whose membership is open to the public)? (section 54E(1)(h)).
10. Have you received any gift (other than a gift from a family member, unless you consider that gift should be disclosed taking into account the purpose of the members' pecuniary interests register) that:
 - has an estimated market value in New Zealand of over \$500; or
 - when combined with all other gifts from the same donor, have a total estimated market value in New Zealand of over \$500? (section 54F(1)(b)); CoC Cl 10.
11. Have you received any payment for an activity in which you are involved, excluding:
 - any salary or allowance paid to you under the Remuneration Authority Act 1977 or the Local Government Act 2002
 - any payment received from an interest that has already been disclosed in this return; or
 - any payment made in respect of an activity that you ceased to be involved in before becoming a member? (section 54F(1)(c)) (section 54F(1)(c)).
12. Are there any other matters which the public might reasonably regard as likely to influence your actions during the course of your duties as a Councillor? CoC Cl 9(e).
