Preface

Proposed Plan Change 6AA to the Regional Plan: Water for Otago was publicly notified on 5 October 2019 in accordance with Clause 5 of the First Schedule of the Resource Management Act 1991 (RMA).

This document summarises the 20 submissions received. Nineteen of these submissions were lodged within the statutory time frame specified, by 5pm on 4 November 2019. The 20th submission was received late. Under delegated authority Otago Regional Council has waived the time limit for this submission.

Any associated further submission in support or opposition is included following its submission point. These are shown in italics. A total of three further submissions were received by the closing date of Friday 22 November 2019.

The eligibility of the further submission received from Fraser McRae will be discussed at the Plan Change hearing, with a focus on:

- Whether Fraser McRae represents a relevant aspect of the public interest and
- Whether the decision requested is allowable or whether it extends the scope of the original submission it relates to.
